

## BUSINESS PROPOSAL FOR TURKISH & ZAMBIAN BUSINESS COMMUNITIES

Type of partnership	Contract manufacturing venture
Relevant product groups	Manufacture of timber <sup>1</sup> products ( <i>or establishing dealerships in Zambia</i> ). Manufacture of organic fertilizer. Production of cooking oil, and associated residual products such as stock-feed. Manufacture of cigarettes. Fish farming. Food processing ( <i>based on especially maize, groundnuts, soya beans, pineapples, sunflower, etc.</i> ) Textiles.
What will Turkish companies provide?	Know-how through skilled manpower, if necessary machinery, and Turkish brand name.
Who will manufacture or assemble?	Zambian partner will provide semi-skilled labour, Turkish partner will provide know-how (including machinery and maintenance services) and train local labour.
Who will set up the manufacture/assemble the facility?	Either completely by the Turkish partner, or in partnership with a Zambian company.
Who will find the land for the facility?	Zambian partner
Any minimum shareholding requirements?	No.
Who will export?	Joint venture company
Any government buying guarantees?	Yes, it will be arranged.
Where will products be exported?	Duty free to COMESA market (incl. Democratic Republic of Congo, Tanzania, and Rwanda, etc.)
Will government be involved?	No. (unless requested) (Originally it is intended as a "private" equity venture)
Who are the potential Zambian partners?	Zambian contactors (Please contact Eng. Eugene Haazele, Chairman of the Business Support Committee of the Association of Consulting Engineers of Zambia (ACEZ), <a href="mailto:eugenehaazele@gmail.com">eugenehaazele@gmail.com</a> , for full contacts of potential Zambian partners who may have interest in such joint ventures.)
Are there any finance plans/options?	<sup>1</sup> Stanbic Bank has a specific finance scheme for such ventures.

Export of timber (from Zambia) is currently prohibited only for raw timber logs. After 1st stage of processing (e.g. timber sheets with minimum specific thickness, etc.), exports seem possible.
